RESOLUTION

No. 49-91

WHEREAS, The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Reservation, and

WHEREAS, The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, education and resources of the Blackfeet Indian Reservation, and

WHEREAS, The Blackfeet Tribal Business Council has been advised of the need for a comprehensive tribal commercial code which addresses the needs, protects the legal rights, and provides legal remedies for debtors, creditors and other business concerns engaging in commercial activity within the exterior boundaries of the Blackfeet Indian Reservation, and

WHEREAS, The Blackfeet Tribal Business Council adopted Resolution No. 353-87, dated April 2, 1987 approving the Blackfeet Commercial Code, and

WHEREAS, After due consideration and based on comments of the Blackfeet Tribal Court and a public hearing held on October 30, 1987, the Blackfeet Tribal Business Council has determined that certain amendments of the Commercial Code are necessary, now

THEREFORE BE IT RESOLVED:

That the Blackfeet Tribal Business Council, pursuant to Article VI, Section 1(k) of the Blackfeet Tribal Constitution, hereby adopts the attached revised Blackfeet Tribal Commercial Code, and all other prior versions of the Blackfeet Commercial Code are hereby replaced with the attached revised Commercial Code.

BE IT FURTHER RESOLVED:

That all portions of the Blackfeet Law and Order Code which are inconsistent with the revised Commercial Code adopted by this Resolution are repealed, including, but not limited to:

Sections 5 and 6A of Chapter 2, Part 1 (Civil Actions, Credit)


All of Chapter 2, Part 2 (Civil Actions, Repossession of Personal Property)

Sections 7, 15, 33, 34, 35, 37, 38 and 39 of Chapter 10 (Small Claims Court); and

BE IT FURTHER RESOLVED: That all judgments of the Blackfeet Tribal Court and the Small Claims Court may be satisfied through any methods provided for in the revised Blackfeet Commercial Code.


