BILL NO. CLB0204

INTRODUCED BY: REPRESENTATIVE ANGELA RUSSELL, VALLEY OF THE CHIEF'S DISTRICT

A BILL FOR AN ACT ENTITLED: ESTABLISHMENT OF LEGISLATIVE SUBCOMMITTEES TO ADVISE EXECUTIVE BRANCH CABINETS.

WHEREAS, the Executive Branch of the Crow Tribal Government has been structured under four Cabinets including Economic Development, Health and Human Services, Natural Resources and Revenue; and

WHEREAS, the Crow Tribal Legislature desires to advise the Cabinets in areas of proposed projects including the development of wind energy, water bottling, zoning along the Big Horn River and Pryor Creek, among other projects for the benefit of the Crow Tribe.

BE IT ENACTED BY THE LEGISLATURE OF THE CROW TRIBE:

NEW SECTION. Section 1. Establishment of five sub-committees of the Crow Tribal Legislature, Economic Development, Health and Human Service, Natural Resources, Revenue and Law and Justice to advise the five Executive Branch Cabinets of the same titles. (1) The Crow Tribal Legislature hereby establishes four sub-committees for the purpose of advising the Executive Branch Cabinets and to consider appropriate Legislation to facilitate the effective project development or delivery of services by the Executive Branch Cabinet. The four sub-committee shall be the Economic Development Sub-Committee, the Health and Human Services Sub-Committee, the Natural Resources Sub-Committee, and the Revenue Sub-Committee.

Further, rules for selection, of the responsibilities, and reporting will be promulgated by the Legislative Branch.
