A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATIVE AND EXECUTIVE BRANCHES TO CONFIRM CHAIRMAN' S SELECTIONS FOR EXECUTIVE BRANCH CABINET HEADS AND CEO

WHEREAS, the Executive Branch of the Crow Tribal Government is empowered to administer and oversee all functions of the Executive Branch of the Crow Tribal Government; and

WHEREAS, the Legislative Branch of the Crow Tribe has a desire to insure that persons selected for the key positions of Cabinet Heads and CEO, are adequately qualified for the positions and to insure that they are adequately qualified shall comply with the following standards, be at least 25 years old, possess a High School Diploma or equivalent, shall have no Felony convictions, to provide for the utmost protection of the Tribal membership, Tribal funds assets and resources; and

WHEREAS, the Executive and Legislative Branches of the Crow Tribe resolve that the Chairman of the Executive Branch shall select Cabinet Heads and CEO, who shall be confirmed into their positions after a hearing before the Legislative Branch.

BE IT RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE CROW TRIBE:

That the Chairman of the Crow Tribal Executive Branch select Cabinet Heads and CEO, that will appear, before the Crow Tribal Legislature for confirmation and approval into their positions after a hearing to discuss the selected persons capabilities for the Cabinet position.




