A JOINT ACTION RESOLUTION OF THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE CROW TRIBAL GOVERNMENT

A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATIVE BRANCH REQUESTING THE CROW TRIBAL EXECUTIVE BRANCH TO DONATE UP TO TEN (10) BUFFALO HUNTS PER YEAR TO THE CROW TRIBAL BOYS AND GIRLS CLUB FOR COMPENSATION TO SPORTS CELEBRITIES IF SUCH CELEBRITIES PROVIDE SPORTS CAMPS OR PROGRAMS FOR THE CROW TRIBAL BOYS AND GIRLS CLUB WITH THIS ADOPTED RESOLUTION TO BECOME A PROVISION OF THE BUFFALO MANAGEMENT PLAN WHEN SUCH PLAN IS COMPLETED

WHEREAS, children of the Crow Reservation are the Tribe's most important assets and they need positive influences and role models to become responsible and productive citizens; and

WHEREAS, sporting contests and programs provide Crow children with virtues such as positive self-esteem, self accomplishment, team accomplishment and motivation to succeed, not only in sports, but life's endeavors as well;

WHEREAS, certain sports celebrities provide positive examples to Crow children regarding such desire virtues; and

WHEREAS, the Executive and Legislative Branches of the Crow Tribe resolves that certain approved sports celebrities should encouraged to visit the Crow Reservation for the purpose of overseeing and instructing sports camps and programs for Crow children, and that the donated buffalo hunts are proper enticement and compensation to such celebrities to provide these services.

BE IT RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE CROW TRIBE:

That the Crow Tribal Legislative Branch requests that the Crow Tribal Executive Branch donate, up to (10) buffalo hunts per year to the Crow Tribal Boys and Girls Club for compensation to sports celebrities if such celebrities provide sports camps or programs for the Boys and Girls Club, and further, that this adopted Resolution is to become a provision of the Crow Tribal Buffalo Management Plan when such plan is complete. Be it further that the Crow Tribal Boys and Girls Club and the Crow Tribal Buffalo Management Office coordinates their activities for the provision of this resolution and reports back each quarterly session of the Crow Tribal Legislative.
