**A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATIVE AND EXECUTIVE  
BRANCHES AUTHORIZING THE CONTINUATION OF AN OLDER AMERICAN ACT, TITLE VI, PART  
A PROGRAM FOR THE CROW TRIBAL SENIOR CITIZENS PROGRAM**

WHEREAS, our Crow Elders are an invaluable resource of cultural, family and historical value to the Crow  
Tribe; and

WHEREAS, many Crow Elders on the Crow Reservation require assistance to assure a high quality of life; and

WHEREAS, a majority of Crow Elders continue to need services provided by the Title VI Project, namely, the  
daily nutritious mean, transportation, information and referral services and other social activities provided; and

WHEREAS, the Executive and Legislative branches of the Crow Tribe concurrently resolve to continue to provide  
Title VI services within the Crow Indian Reservation services area which includes the total area within the  
exterior boundaries as described by Tribal maps

**BE IT JOINTLY RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE CROW  
TRIBE:**

That both the Executive and Legislative Branches of the Crow Tribal

Government support and endorse the grant application for assistance for the Crow Tribal Elders pursuant to the  
older American Act, Title VI, Part A.

**CODIFICATION. Section 1. Codification instruction.** This Joint Action Resolution, upon adoption by the  
Crow Tribal Legislature, is intended to be codified as appropriate in Title(s) \_\_\_\_\_ of  
the Crow Tribal Law and Order Code.
