**A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES
OF THE GOVERNMENT**

**A JOINT RESOLUTION ENTITLED: TO PROMOTE THE DEVELOPMENT OF STATE-
TRIBAL COOPERATIVE AGREEMENT FOR THE MANAGEMENT OF PLENTY COUPS
STATE PARK WITHIN THE EXTERIOR BOUNDARIES OF THE CROW RESERVATION.**

WHEREAS, the last Chief of the Crow Tribe, Plenty Coups, donated his property within the exterior boundaries of the Crow Reservation near the town of Pryor, Montana, to be used as a park for all peoples with the intent of promoting cultural understanding of Indians and non-Indians; and

WHEREAS, Plenty Coups State Parks serves as an Archives and Museum for historical records, artifacts, and photographs, of Chief Plenty Coups and the history and culture of Crow People; and

WHEREAS, Plenty Coups State Park has been managed by the State of Montana, Department of Wildlife, and Parks since 1965; and

WHEREAS, the Montana Department of Fish, Wildlife, and Parks, manages primarily fish and wildlife projects, and historical, cultural and museum management requires a partnership of many sources; and

WHEREAS, the Montana Legislature has enacted legislation to promote State-Tribal Agreements in those areas where a State and Tribe can work together on a common project; and

WHEREAS, a non-profit organization, the Friends of Chief Plenty Coups, already exists to assist and promote the development with the Crow Tribe of this State-Tribal Agreement.

**BE IT JOINTLY RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF
THE CROW TRIBE:**

That the Crow Tribe promote the development of a State of Montana-Tribal Cooperative Agreement for tribal management of Plenty Coups State Park in cooperation with the Friends of Chief Plenty Coups.
