

**JANUARY 2002 CROW TRIBAL LEGISLATURE**

JOINT ACTION RESOLUTION NO: JAR0212

INTRODUCED BY: REPRESENTATIVE LLOYD HOGAN, CENTER LODGE DISTRICT

A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBAL GOVERNMENT TO REQUIRE THE DEPARTMENT OF HEALTH AND HUMAN SERVICES TO SEEK AND APPLY FOR FUNDING THROUGH PUBLIC AND PRIVATE SOURCES IN ORDER TO ESTABLISH AND OPERATE A TRIBAL GROUP HOME FOR TROUBLED YOUTH ON THE CROW INDIAN RESERVATION AND TO AUTHORIZE THE PROMULGATION, ADOPTION AND IMPLEMENTATION OF ANY RULES, REGULATIONS OR ORDINANCES NECESSARY TO ESTABLISH AND ADMINISTER SUCH FACILITY IN ACCORDANCE WITH ANY APPLICABLE LAWS REQUIRED TO MAINTAIN SUCH FUNDING.

WHEREAS, the Crow Tribal Legislative and Executive Branches of the Tribal Government acknowledge and agree that the Crow Reservation lacks a treatment facility for troubled youth who are plagued by mental health issues cause by drug and alcohol abuse, physical abuse as well as numerous other causes; and

WHEREAS, such shortage results in the youth of the Crow Tribe being placed in treatment facilities off of the Crow Reservation resulting in the youth losing their tribal identity due to their separation and lack of contact with friends, family and the unique culture of Reservation life; and

WHEREAS, the Crow Tribe is losing out on potential funding for a tribal group home while other Tribes are accessing funds through public and private sources to enable the operation of Tribal facilities on their respective Reservations.

BE IT JOINTLY RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE:


That the Executive Branch of the Crow Tribal Government through the Department of Health and Human Services to public and private sources to enable the Crow Tribe to provide a therapeutic group home on the Reservation for the treatment of troubled youth, 12 to 18 years of age. The Department of Health and Human Services if further ordered to prepare and submit a joint report to the Legislature and Executive Branches regarding its efforts at the April Session.
