A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBAL GOVERNMENT

A RESOLUTION ESTABLISHING A JUNK VEHICLE PROGRAM FOR THE CROW RESERVATION IN COOPERATION WITH BIG HORN COUNTY.

WHEREAS, the Crow Tribe currently has no governmental program to control the number of junk vehicles in our reservation communities; and

WHEREAS, the junk vehicles in our communities pose public health, environmental and aesthetic problems; and

WHEREAS, there is a recognition some tribal members collect and store junk vehicles as a business but still should be required to establish a parameter and shield for their business; and

WHEREAS, Big Horn County has already established a junk vehicle program with the major cost being the transportation from the pickup site to the crushing site; and

WHEREAS, tribal lands adjacent to our major communities of Wyola, Lodge Grass, Crow Agency, St. Xavier, Ft. Smith, and Pryor, should be designated as pickup sites for these junk vehicles; and

WHEREAS, the Executive and Legislative Branches of the Crow Tribe should promulgate policy and rules for the further control and disposal of junk vehicles;

THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE:

New Section. Section 1. To establish a junk vehicle program for the Crow Reservation in cooperation with Big Horn County by designating pickup sites in our six major communities and to establish policy and rules for the further control and disposal of junk vehicles.

New Section. Section 2. Codification instructions.
