JOINT ACTION RESOLUTION NO. JAR0221

INTRODUCED BY : REPRESENTATIVES SCOTT MEDICINE HORSE, VALLEY OF THE CHIEFS DISTRICT , AND OLIVER COSTA, ARROW CREEK DISTRICT

A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBAL GOVERNMENT

A JOINT ACTION RESOLUTION DESIGNATING ALL EXCESS MILLINGS DONATED TO THE CROW TRIBE FOR DRIVEWAYS AND ROADS OWNED BY TRIBAL ELDERS OR LOCATED NEAR THE HOMES OF CROW TRIBAL ELDERS FOR THE BENEFIT OF THE TRIBAL ELDERS AND TO NEGOTIATE WITH BUREAU OF INDIAN AFFAIRS FOR SNOW PLOWING SERVICES FOR ALL THE COMMUNITIES ON CROW INDIAN RESERVATION

WHEREAS, the Crow Tribe traditionally respects and cares for its elders; and

WHEREAS, many of the elders cannot afford to pave the roads and driveways owned by them or located near their property;

WHEREAS, a significant amount of millings is donated to the Crow Tribe when there is road or highway construction in the vicinity of the Reservation; and

WHEREAS, many communities do not have regular snowplow services in winter months, which causes great hardship to many residents, Tribal elders, disabled persons and travelers in carrying out regular and business activities.

THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE:

Section 1. 1. To designate all excess millings donated to the Crow Tribe for driveways and roads owned by or near homes of tribal elders and disabled persons, expressly for the benefit and care of the tribal elders and disabled persons; and

Be it further resolved that the Executive Branch of the Crow Tribal Government, at the request of the Legislative Branch of the Crow Tribal Government, will negotiate with the BIA for regular snow plowing services to benefit the residents and elders of our communities with business and regular travel during winter months.


