**A JOINT ACTION RESOLUTION OF THE EXECUTIVE AND LEGISLATIVE BRANCHES  
OF THE CROW TRIBAL GOVERNMENT**

**A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATIVE BRANCH  
REQUESTING THE CROW TRIBAL EXECUTIVE BRANCH TO SEEK GRANTS AND  
FINANCIAL AID TO ASSIST TRIBAL MEMBERS IN RURAL AREAS OF THE CROW  
RESERVATION IN ACQUIRING FUNDS TO OFFSET COSTS INCURRED BY  
INSTALLATION OF ELECTRICAL SERVICE LINES TO REMOTE PROPERTIES**

WHEREAS, many Crow Tribal members living in remote areas of the Reservation incur high costs for the installation of electrical service lines to such properties and are therefore prohibited from electrifying such properties; and

WHEREAS, the electrification of remote properties on the Crow Reservation benefits those Tribal lands and property owners and further promotes economic development for the entire Crow Reservation; and

WHEREAS, the Executive and Legislative Branches of the Crow Tribe resolve that rural property owners and the entire population of the Crow Reservation will benefit if rural property is electrified through cost effective means which may be possible through grants or financial aid for such services.

**BE IT RESOLVED BY THE EXECUTIVE AND LEGISLATIVE BRANCHES OF THE  
CROW TRIBE:**

That the Crow Tribal Legislative Branch requests that the Crow Tribal Executive Branch seek, through its Tribal Contracts Office, grants and financial aid programs to benefit rural property owners of the Crow Reservation which offset the high costs incurred to electrify rural and remote properties on the Crow Reservation.
