A JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE

DIRECTING THE CROW TRIBAL FISCAL OFFICE TO IDENTIFY \$10,000.00 FOR DISTRIBUTION TO LOCAL CHURCHES SPONSORING CAMP MEETINGS THROUGHOUT THE CROW INDIAN RESERVATION.

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe Indians, approved by the Secretary of Interior on July 14, 2001; and

WHEREAS, the Crow Tribal government has historically provided financial assistance to local churches sponsoring camp meetings throughout the Crow Indian Reservation, but no procedures have previously been implemented to govern this process; and

WHEREAS, camp meetings held in the various districts of the Crow Reservation serve the purpose of bringing Crow Tribal members together as a community; and

WHEREAS, the Crow Tribal Legislature finds it to be in the best interest of the Crow Tribe and Tribal members to continue supporting local churches through their camp meetings through financial assistance.

BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

THEREFORE: The Crow Tribal Legislature hereby directs the Crow Tribal Fiscal Office to identify \$10,000.00 annually, beginning in the summer, 2002, for distribution to local churches sponsoring camp meetings throughout the Crow Indian Reservation.

THEREFORE: The Crow Tribal Legislature further directs that the receipt of financial assistance by local churches shall be contingent upon the following:

- a. Those local churches desiring to sponsor a camp meeting and receive financial assistance from the Tribe must submit their name to the Fiscal Office prior to the end of each fiscal year, on September 30.
- b. On November 1st of each year, the Fiscal office shall compile a complete list of all churches and scheduled church meetings, which are in compliance with 2(a).



- c. Those churches included on the Fiscal Office's list must coordinate a schedule of events, such that no scheduled camp meetings conflicts with each other, and submit this schedule to the Fiscal Office by May of each year.
- d. The total amounts of \$10,000 shall be distributed evenly among all organizations included on the list as mentioned above and shall be made available no later than one month prior to the scheduled camp meetings.

THEREFORE: The Crow Tribal Legislature further directs that the financial assistance contemplated in this resolution shall continue each year into the future, provided that the monies are included and approved as part of the Crow Tribal Budget for each year.

THEREFORE: The Crow Tribal Legislature finally directs this resolution shall be effective upon approval by the Executive Branch.
