

**JANUARY 2002 CROW TRIBAL LEGISLATURE**

**JOINT ACTION RESOLUTION NO. JAR0229**

**INTRODUCED BY: REPRESENTATIVE ANGELA RUSSELL, VALLEY OF THE CHIEFS DISTRICT AND MICHAEL NOT AFRAID, BLACK LODGE DISTRICT**

A JOINT ACTION RESOLUTION OF THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE: TO ESTABLISH A PLANNING COMMITTEE TO PROMOTE THE DEVELOPMENT OF A CROW INDIAN MUSEUM UTILIZING THE PAUL DYKE COLLECTION AND TO PROVIDE FUNDS FOR THE COMMITTEE.

WHEREAS, Mr. Paul Dyke of Sedona, Arizona, has expressed interest in developing a museum with the Crow Tribe which would display his collection of over 30,000 artifacts of the Plains Indians; and

WHEREAS, Mr. Paul Dyke currently owns land (forty acres) near the Little Big Horn Battlefield which is his proposed site for the museum and which is a high trafficked tourist area; and

WHEREAS, the Crow Tribe has an interest in the development of a museum to display and store cultural artifacts of the Crow and other Plains Indians for educational purposes and economic development; and

WHEREAS, a Museum Planning Committee comprised of three (3) representatives from the Legislative Branch, three (3) representatives from the Executive Branch, and three (3) members from the Crow public shall be established to begin discussion on the feasibility of the development of a museum; and

WHEREAS, the Executive Committee is directed to provide up to \$3,000.00 for the Museum Planning Committee to begin the planning portion of this proposed project;

THEREFORE BE IT ENACTED BY THE LEGISLATURE OF THE CROW TRIBE TO ESTABLISH A MUSEUM PLANNING COMMITTEE TO PROMOTE THE DEVELOPMENT OF A CROW INDIAN MUSEUM UTILIZING THE PAUL DYKE COLLECTION AND TO PROVIDE FUNDS FOR THE COMMITTEE.
