**INTRODUCED BY CARL E. VENNE, CHAIRMAN
CROW TRIBAL EXECUTIVE BRANCH**

**JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE
CROW TRIBAL EXECUTIVE BRANCH ENTITLED "A JOINT RESOLUTION IN
SUPPORT OF HAVING THE TRIBAL EXECUTIVE BRANCH AGENCIES AND THE
LEGISLATIVE SUBCOMMITTEES WORK TOGETHER IN DEVELOPING
WATER AND AIR QUALITY CODES FOR THE CROW RESERVATION."**

WHEREAS, Article V, Section 2 of the Constitution and Bylaws of the Crow Tribe of Indians authorizes the Legislative Branch to promulgate and adopt laws, resolutions, ordinances, codes, regulations and guidelines in accordance with the Constitution; and

WHEREAS, Article IV, Section 3(j) of the Constitution makes it the responsibility of the Executive Branch to protect and preserve the property, wildlife, and natural resources including air and water of the Tribe in accordance with ordinances adopted by the Legislative Branch; and

WHEREAS, the Crow Tribe does not currently have its own Water Quality and Air Quality laws and regulations, and the otherwise applicable Federal law does not fully protect the resources and unique cultural values of the Crow Tribe;


NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

"That the Crow Tribal Legislature acting jointly with the Crow Tribal Executive Branch hereby authorizes and directs the Crow Environmental Protection Office, and Natural Resources Department, the Tribal Legal Department, and other Executive Branch agencies to work together with the Health and Human Service Subcommittee, Natural Resources Subcommittee, and the Water Commission of the Crow Tribal Legislature to develop Tribal Water Quality and Air Quality Codes for consideration by the Legislature in the October 2003 Regular Session."


