**JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND  
THE CROW TRIBAL EXECUTIVE BRANCH ENTITLED:**

**“APPROVAL OF AN ADDENDUM TO THE EXPLORATION AND OPTION TO  
LEASE AGREEMENT BETWEEN WESTMORELAND RESOURCES, INC. AND THE  
CROW TRIBE DATED FEBRUARY 13, 2004.”**

**WHEREAS**, Westmoreland Resources, Inc. (“WRI”) currently operates the Absaloka Mine in the “ceded strip” pursuant to an amended coal mining lease with the Crow Tribe dated November 26, 1974 (“Tract III Lease”); and

**WHEREAS**, the Crow Tribe and WRI entered into an “Exploration and Option to Lease Agreement” on February 13, 2004, providing for, among other things, the option to lease the “South Extension” area and amending the royalty rate and other terms of the Tract III Lease, and the Agreement was approved by the Bureau of Indian Affairs on September 28, 2004; and

**WHEREAS**, WRI’s tax and royalty payments under the Tract III Lease have been made by mailing checks to the Superintendent, which results in delays in the Tribe’s receipt of the payments and loss of interest income, and the payment and reporting terms in the Exploration and Option to Lease Agreement require clarification; and

**WHEREAS**, since the U.S. District Court’s order in Case No. CV-78-110-BLG-JFB (D. Mont., Sept. 19, 1988), Tribal severance and gross proceeds tax payments from the Absaloka Mine have been treated as trust income; and

**WHEREAS**, the Minerals Management Service (“MMS”) of the U.S. Department of Interior has reviewed and concurs with the Addendum, and WRI has agreed to and executed the Addendum; and

**WHEREAS**, the Chairman of the Executive Branch has authority and responsibility pursuant to the “enumerated powers” in Article IV, Section 3(f) of the Constitution and Bylaws of the Crow Tribe of Indians to “negotiate and approve or prevent any sale, disposition, lease or encumbrance of Tribal lands, interests in lands or other Tribal assets, including buffalo, minerals, gas and oil with final approval granted by the Legislative Branch,” and



**WHEREAS**, the Legislative Branch has authority and responsibility pursuant to its "powers and duties" in Article V, Section 2(d) of the Constitution "to grant final approval or disapproval of items negotiated by the Executive Branch of Government pertinent to the sale, disposition, lease or encumbrance of Tribal lands, interests in lands or mineral assets;" and

**WHEREAS**, the reporting and payment methods specified in the Addendum will ensure that payments are credited to the Tribe's accounts in a timely manner consistent with modern banking practices, that MMS can properly verify royalty payments, and that funds from tax and royalty payments continue to be managed by the Office of the Special Trustee of the U.S. Department of the Interior and disbursed according to the Tribal budget;

**NOW THEREFORE, BE IT RESOLVED BY THE LEGISLATURE AND THE EXECUTIVE BRANCH OF THE CROW TRIBE:**


**"That the Crow Tribal Legislature acting jointly with the Crow Tribal Executive Branch hereby approves the "ADDENDUM TO EXPLORATION AND OPTION TO LEASE AGREEMENT Between the Crow Tribe of Indians and Westmoreland Resources, Inc., Dated February 13, 2004" negotiated by the Chairman of the Executive Branch, attached and incorporated by this reference, to be effective immediately upon approval by the Bureau of Indian Affairs pursuant to the Indian Mineral Development Act of 1982."**

***ADDENDUM TO EXPLORATION AND OPTION TO LEASE AGREEMENT***

**Between the Crow Tribe of Indians and Westmoreland Resources, Inc.**

**Dated February 13, 2004**

THIS ADDENDUM amends that certain "Exploration and Option to Lease Agreement" dated February 13, 2004 (the "Agreement") between the Crow Tribe of Indians (the "Tribe") and Westmoreland Resources, Inc. ("Westmoreland") with respect to Westmoreland's payment and reporting obligations under the Agreement and the "Coal Mining Lease" attached to the Agreement as Exhibit A (the "Lease"). This Addendum also amends that certain "Amended Coal Mining Lease Indian Lands" dated November 26, 1974 (the "Tract III Lease") as subsequently amended, including the amendments in Section 6 of the Agreement, and shall apply to Westmoreland's reporting and payment obligations under the Tract III lease after the date of execution of this Addendum.

Westmoreland recognizes the reporting, accounting, and auditing functions performed by Minerals Management Service ("MMS") in connection with the lease of coal owned by the Crow Tribe of Indians, and Westmoreland agrees to comply with MMS reporting and auditing requirements at 30 C.F.R. §§ 210.200-210.206 (Forms and Reports); § 212.200 (Records and File Maintenance, § 217.200 (Audits); §§218.10-218.42 & 218.200-218.203 (Collection of Royalties, Rentals, etc); §§228.1-228.10 (Cooperative Agreements); Part 243 (Suspensions Pending Appeal and Bonding); and Part 290, Subpart B (Appeals) (including any future modified versions of these



regulations) on all rent, royalty, and bonus payments under the Agreement and Lease and under the Tract III Lease referenced above.

Further, notwithstanding any other provision of the Agreement or the Lease or the Tract III Lease (including but not limited to Section 22.1 of the Agreement, Article 7.1 of the Lease, and any other provisions referring to Westmoreland making payment to the Superintendent), all payments by Westmoreland to the Tribe, including without limitation, royalties, taxes (characterized as trust funds by order of the United States District Court in Case No. CV-78-110-BLG-JFB (D. Mont., Sept. 19, 1988)), rentals, bonuses and lump sum payments under the Agreement and Lease and the Tract III Lease shall be made by electronic funds transfer to the Office of the Special Trustee for American Indians of the United States Department of the Interior into an account or accounts designated by the Crow Tribe and approved by the Superintendent, except that the payment referred to in section 7 of the Agreement shall be made directly to the Crow Tribe as provided therein.




