**JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND
THE CROW TRIBAL EXECUTIVE BRANCH ENTITLED:**

**“ADDITIONAL LEASE PROPERTY FOR THE ESTABLISHMENT OF THE
ARROW CREEK COMMUNITY COMPLEX INCLUDING TO LEASE OF
TRIBAL PROPERTY TO THE ARROW CREEK VOTING DISTRICT AND
ESTABLISHMENT OF THE PURPOSE FOR THE LEASED PROPERTY THAT
BEING COMMUNITY SERVICE.”**

WHEREAS, under Article IV, Section 3(f) of the constitution, the Executive Branch has the power and responsibility to approve or prevent any sale, disposition, lease or encumbrance of Tribal lands, interests in land or other Tribal assets, with final approval granted by the Legislative Branch;

WHEREAS, under Article V, Section 2(d), the Legislative branch has the power and duty to grant final approval or disapproval of Executive Branch disposition of Tribal Lands, ID.;

WHEREAS, the Tribe desires and intends by this and other action to support and improve the health, welfare and safety of the districts of the Crow Reservation and has made funds available to support governmental and community projects; and


WHEREAS, the citizens of Arrow Creek District and their Legislative representatives desire to utilize tribal resources to develop a local district government and community center with the intended improvement of the health, welfare and safety of the Tribal members’

**NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE AND THE
EXECUTIVE BRANCH OF THE CROW TRIBE:**

Section 1. That an additional parcel of Tribal Property (79.67) acres M/L) for a 25 year lease with an option of renewal for an additional 25-year lease is hereby this action authorized and shall be granted with all necessary legal paperwork to be prepared and finalized as soon as possible, relative to the following property legal description.

TRACT: T-2007-A, T.5S., R.26E., Sec. 3: Lot 3, SE1/4NW1/4, CONTAINING 79.67 ACRES MORE OR LESS

The herein above described property shall be leased at no cost to the enrolled members of the Arrow Creek District as a whole.

Section 2. That the land shall be used exclusively for governmental offices, affairs and community functions, including recreation and future local and tribal administrative needs; and that all future uses and functions shall comply with this purpose.


Section 3. That notwithstanding the lease described in Section 1, the land shall remain in trust status for the Tribe.

Section 4. The additional designated leased land shall be included in and named the Arrow Creek Community Complex.

Section 5. That the rules for the use and development of the Arrow Creek Community Complex shall be approved by the Legislators upon submission by the Arrow Creek Legislators and the Arrow Creek Task Force/ Arrow Creek Tribal members.

Section 6. Attached, incorporated by reference and made a part of as stated herein is the legal map of the description of land to be leased to the Arrow Creek District as Exhibit A.

Section 7 By this action any and all former leases of this property including home site grants or other leases in any form are hereby cancelled.




