**A LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE
APPROVING AND ADOPTING THE INTERNAL OPERATION RULES FOR
CONFIRMATION OF EXECUTIVE BRANCH APPOINTMENTS.**

WHEREAS, the Crow Legislature is required by law to consider, from time to time, appointments by the Chairman of the Executive Branch for confirmation; and

WHEREAS, confirmation of appointments does not involve the adoption or enactment of legislation; and

WHEREAS, a standard internal operating procedure for consideration of appointments will serve the best interests of the Legislature, the Executive, and the citizens of the Apsaalooke Nation.

**NOW THEREFORE BE IT RESOLVED BY THE CROW TRIBAL
LEGISLATURE:**

THAT, requests for confirmation of appointments by the Chairman of the Executive Branch shall be conveyed to the Crow Legislature in writing, designating the name of the appointee, the position for which the appointment is made, and the statutory qualifications which are required.


FURTHER, a request for confirmation of an appointment may be sent to the Legislature by the Chairman at any time. If the legislature is sitting in regular session, consideration of the appointment will be promptly scheduled in the normal course of legislative business. The Legislature may consider confirmation during a special session, whether called specifically for that purpose or called to consider other matters.

FINALLY, the Legislative consideration of a request for confirmation shall be for the purpose of determining whether the appointee is qualified. If a majority of the legislators present and comprising a quorum concur that the appointee meets the standards set forth, a Resolution of confirmation shall be signed by the Speaker and certified by the Secretary of the Legislature.




CERTIFICATION
