ENTITLED:

“AN LR ESTABLISHING A SURFACE LAND SUB-COMMITTEE”

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians

WHEREAS: the Legislature has reviewed the issues related to land, and

WHEREAS: the issues related to Land are unique and should be reviewed separately because of the magnitude of issues related thereto, and

NOW THEREFORE, BE IT RESOLVED:


BY THIS ACTION THE CROW LEGISLATURE HEREBY DOES ESTABLISH THE SURFACE LAND SUBCOMMITTEE.

THE SURFACE LAND SUBCOMMITTEE SHALL BE PRIMARILY RESPONSIBLE FOR THE REVIEW, CONSIDERATION AND DEVELOPMENT OF LEGISLATION RELATING TO ISSUES OF LAND AND LAND AS A TRIBAL RESOURCE.

THIS RESOLUTION SHALL TAKE EFFECT IMMEDIATELY UPON PASSAGES BY THE CROW LEGISLATURE.
