A LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE  
ENTITLED:

**“AN LR RESCINDING LR-07-05 A RESOLUTION ESTABLISHING A PROGRAM  
WHEREIN THE LEGISLATOR’S THAT DO NOT GET ELECTED HAVE A RIGHT  
TO RECEIVE SEVERANCE PAY AT THE ESTABLISHED HOURLY RATE FOR A  
PERIOD OF UP TO 90 DAYS AFTER ELECTION.”**

**WHEREAS**, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians

**WHEREAS**: after careful and extended review of the issue the Legislature has concluded that LR07-05 is not appropriate and does not comply with the Legislature’s future ability to provide funds thereto.


**NOW THEREFORE, BE IT RESOLVED:**

BY THIS ACTION LR 07-05 IS HEREBY RESCINDED AND SHALL HAVE NO FURTHER EFFECT OF LAW AS IT RELATES TO THE CROW LEGISLATURE.


THIS RESOLUTION SHALL TAKE EFFECT IMMEDIATELY UPON PASSAGES BY THE CROW LEGISLATURE.
