A LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE  
ENTITLED:

**“ESTABLISHMENT, ADOPTION AND APPROVAL OF BYLAWS FOR THE CROW  
LEGISLATURE’S EDUCATION SUBCOMMITTEE”**

**WHEREAS**, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians

**WHEREAS**, the Crow Tribal Legislature approved the establishment of the EDUCATION Subcommittee to provide for orderly and efficient review and recommendation of EDUCATION related issues and matters to and for the Legislature, and

**WHEREAS**: the Crow Legislature hereby finds it reasonable, necessary, proper and legal to establish bylaws for the EDUCATION Subcommittee.

**NOW THEREFORE, BE IT RESOLVED:**

**THE EDUCATION SUBCOMMITTEE BYLAWS ARE HEREBY THIS OFFICIAL  
ACTION AUTHORIZED, ADOPTED, AND APPROVED AS FOLLOWS:**


**BY-LAWS OF THE EDUCATION SUBCOMMITTEE  
OF THE: CROW TRIBAL LEGISLATURE**

**I. Establishment affirmed**

The EDUCATION Subcommittee is hereby recognized, authorized and continued as an official recognized standing subcommittee of the Crow Tribal Legislature

**II. Membership; Legislative Advisors**

- A. The Subcommittee shall consist of members of the Crow Tribal Legislature.**  
1. The members shall each year in January select a Chairman and a Secretary.

- B. The Subcommittee shall coordinate with other Subcommittees as necessary, the designated/proper Executive Branch Cabinet Head, and the Legislative Attorney on matters within the Subcommittee's authority and may request appropriate support, advice and counsel on all matters within the scope of the subcommittee.

### III. Purposes


The purposes of the EDUCATION Subcommittee are:

- A. To draft and recommend, original legislation and amendments, and promote policies pertaining to the development and improvement of EDUCATION for children and adult Members, while maintaining and asserting the Culture and Traditions of the Crow Tribe.
- B. To recommend to the Crow Tribal Legislature the adoption of legislation designed to strengthen the EDUCATION resources of the Crow Tribe and to promote the development of businesses and increased employment for the Crow Tribe and its members with a goal of economic independence and security.
- C. To assist, draft and make recommendations to the Legislature in the development of EDUCATION rules, regulations and laws.

### IV. Powers

The Subcommittee shall have all powers necessary and proper to carry out the purposes set forth above, including

- A. To draft and recommend laws, rules and regulations governing Crow Tribal EDUCATION for final approval by the Legislature. Such laws, rules and regulations shall set forth the policies and standards to be followed in all EDUCATION related areas within the boundaries of the Crow Reservation.
- B. To research and obtain from the schools and college all available education data and information on all Crow member students. Retrieve, compile, analyze and review and recommend for approval to the Legislature all policies, laws, rules and regulations for the improvement of EDUCATION for all Crow students...
- C. To draft and recommend polices, guidelines, rules and regulations concerning EDUCATION matters, including but not limited to proposals for new schools and facilities to assist in local enterprise development and other related business development etc. for the Crow Tribe and tribal members.
- D. To propose or review all legislation relating to the EDUCATION Subcommittee and EDUCATION related business within the Crow Tribe and shall recommend the adoption or amendment of such EDUCATION related laws, rules or regulations to the Crow Tribal Legislature,



- E. To receive reports from and to review the operations of all offices, divisions, departments, enterprises, committees, boards, commissions or entities having oversight or control over EDUCATION matters.
- F. To hold hearings relative to the functioning, excluding personnel and/or administrative matters, of the EDUCATION/ Department.
- G. To review any and all legislative proposals concerning EDUCATION related matters upon referral by the Crow Tribal Legislature.

V. Meetings.


Meetings shall be held on the \_\_\_\_\_ of each month.


### CERTIFICATION
