**LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE
ENTITLED:**

**“MILEAGE REPARATION FOR LEGISLATIVE SENATORS
DURING SESSIONS”**

WHEREAS, The Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Crow Tribal General Council July 14th 2001 and signed by the Secretary of the Interior on December 04th 2001; and

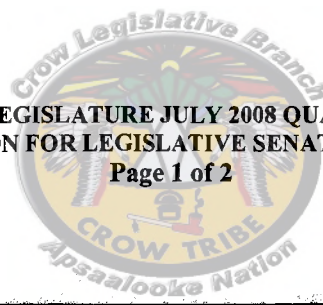
WHEREAS, the Crow Tribal Legislature hereby declares that Legislative Resolutions are those items that merely express an opinion of the Legislature, or request/recommend another entity to take a certain action (the request or recommendation has no binding effect, but rather expresses the Legislatures support for something.) Legislative Resolutions shall also be used for internal legislative actions and shall only be binding upon the Legislative Branch; and

WHEREAS, the Crow Tribal Legislature Revenue Committee convened a meeting on July 2nd 2008, approving mileage reparation for the Legislative Senators during sessions; and

WHEREAS, the Crow Tribal Legislature finds it to be costly to travel with the rising cost of gas prices; and

WHEREAS, the economy of gas prices are rapidly ascending showing no action of decreasing; and

WHEREAS, the economy inflation is dramatically effecting the Senator traveling from home to the Legislative Chambers to convene sessions.



NOW THEREFORE BE IT ENACTED BY THE CROW TRIBAL LEGISLATURE:

THAT, THE CROW TRIBAL LEGISLATURE DOES ESTABLISH MILEAGE REPERATION FOR THE LEGISLATIVE SENATORS DURING SESSIONS.

FURTHER, UPON APPROVAL OF THIS LEGISLATIVE RESOLUTION MILEAGE REPERATION SHALL BE EFFECTIVE IMMEDIATELY.

FURTHER, THIS LEGISLATION DOES NOT INCLUDE RETRO REPERATION.


FINALLY, THAT THIS LEGISLATIVE RESOLUTION UPON APPROVAL SHALL BE AMENDED FROM TIME TO TIME FOR FINANCIAL PURPOSES. AND ALL RELEVANT AND NECESSARY DOCUMENTS ARE ATTACHED HERETO AS EXHIBIT (A). FUNDS ARE HEREBY APPROPRIATED AS FOLLOWS:

\$30,000.00 FROM LEGISLATIVE BUDGET LINE ITEM 66200 TRAVEL OFF RESERVATION TO LEGISLATIVE BUDGET LINE ITEM 64440 FOR LEGISLATIVE MEMBER MILEAGE.

EACH MEMBER REQUESTING MILEAGE PAYMENT MUST SUBMIT A MILEAGE INVOICE AND LEGISLATIVE STAFF SHALL CORRECT ALL TYPOGRAPHICAL ERRORS IN THIS LR

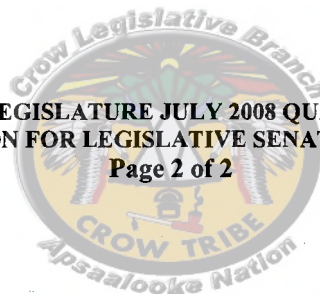
