**LEGISLATIVE RESOLUTION OF THE CROW TRIBAL
LEGISLATURE ENTITLED:**

**“A RESOLUTION CLARIFYING POLICY AND AUTHORIZING
LEGISLATORS TO REGISTER AND SERVE IN EMERGENCY
SITUATIONS PURSUANT TO ARTICLE III, SECTION 2(3)a OF THE
ELECTION ORDINANCE”**


**WHEREAS, the Crow Legislature is a separate Branch of the
Crow Government, and**

**WHEREAS, the Crow Legislature has the authority as a separate
Branch of the Crow Government to establish policies relative to
the operation and management of the Branch, and**

**WHEREAS, that certain members of the Crow Tribal Legislature
were previously employed through temporary employment on an
as needed or on-call basis in cases of emergency, and**

**WHEREAS, the Election Ordinance CLB 05-15 states that “All
candidates for legislative branch offices, if elected, must resign
from employment with the Crow Tribe, the United States, or the
State of Montana or any subdivision thereof prior to taking the
oath of office...the employment purposes for candidacy
qualifications shall not include temporary, part-time service due
to emergency situations, such as serving as a federal, state or
tribal firefighter or serving in the National Guard, military reserve
forces or as Tribal Homeland Security.**

**WHEREAS, the Crow Legislature clearly encourages the
support, preservation and continued maintenance of the safety,
health and welfare of Members of the Crow Tribe of Indians and
the United States Government, and**



WHEREAS, the Election Ordinance clearly grants an exception to legislators to serve in emergency situations.

NOW THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE BRANCH OF THE CROW TRIBE:

THE CROW LEGISLATIVE BRANCH SUPPORTS AND ENCOURAGES THE LEGISLATIVE MEMBERS TO SERVE IN EMERGENCY SITUATIONS.

THERE IS HEREBY ESTABLISHED THE CROW LEGISLATIVE POLICY, AUTHORIZATION AND SUPPORT FOR ALL CROW LEGISLATIVE MEMBERS WHO DESIRE TO ASSIST IN EMERGENCY SITUATIONS AND TO BE PLACED ON AN ON-CALL ROSTER FOR CERTAIN DEPARTMENTS OR AGENCIES.


CERTIFICATION
