A LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE
ENTITLED:

**“AUTHORIZATION TO DARCY MERCHANT OF IHS TO MAKE PUBLIC DATA
INFORMATION GAINED IN THE RESEARCH OF AUTOMOBILE ACCIDENTS ON
THE CROW RESERVATION”**

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians

WHEREAS, the Crow Tribal Legislature approved Rules of Order to provide for orderly and efficient Legislative sessions, and

WHEREAS, the Crow Legislature and the Health and Human Services committee had previously authorized Darcy Merchant to conduct the research study of accidents on highways on the Crow Reservation, and


WHEREAS, the Crow Legislature in Regular Session determined that for highway safety purposes on the Crow Reservation it is desirable to share research data information gained in a study conducted by Darcy Merchant of IHS as to accidents on the Crow Reservation , and

WHEREAS, the purpose of sharing this research data information is to improve the health, welfare and safety for all Members of the Crow Tribe of Indians

WHEREAS, Darcy Merchant has provided assurance that the information being shared publically will not infringe on the individual PRIVACY rights of Crow Tribal Members, and


NOW THEREFORE, BE IT RESOLVED:

**WITH THE CLEAR UNDERSTANDING AND AS A CONDITION
PRECEDENT THAT THE PRIVACY OF CROW TRIBAL MEMBERS SHALL BE
PROTECTED AT ALL TIMES, THE CROW LEGISLATURE HEREBY THIS
ACTION AUTHORIZES DARCY MERCHANT TO PUBLICALLY SHARE THE
RESEARCH DATA OBTAINED AS TO ACCIDENTS ON HIGHWAYS ON THE
CROW RESERVATION.**





CERTIFICATION
