A LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE ENTITLED:

"AN LR ESTABLISHING AN ENROLLMENT SUBCOMMITTEE"

WHEREAS, the Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians

WHEREAS, the Legislature has reviewed the issues related to enrollment, and

WHEREAS, the issues related to enrollment are unique and should be reviewed separately because of the magnitude of issues related thereto, and

NOW THEREFORE, BE IT RESOLVED:

BY THIS ACTION THE CROW LEGISLATURE HEREBY DOES ESTABLISH THE ENROLLMENT SUBCOMMITTEE.

THE ENROLLMENT SUBCOMMITTEE SHALL BE PRIMARILY RESPONSIBLE FOR THE REVIEW, CONSIDERATION AND DEVELOPMENT OF LEGISLATION AND RECOMMENDATIONS RELATING TO ISSUES OF ENROLLMENT AND MEMBERS AS A "MOST VALUABLE" TRIBAL RESOURCE.

THE ESTABLISHED CROW LEGISLATURE RULES OF ORDER SHALL APPLY AT ALL TIMES TO THIS ESTABLISHED ENROLLMENT SUBCOMMITTEE.

THE ATTACHED, INCORPORATED BY REFERENCE AS IF STATED HEREIN BYLAWS ARE HERBY ESTABLISHED, ADOPTED AND APPROVED.

THIS RESOLUTION SHALL TAKE EFFECT IMMEDIATELY UPON PASSAGES BY THE CROW LEGISLATURE.

BY-LAWS OF THE ENROLLMENT SUBCOMMITTEE OF THE CROW TRIBAL LEGISLATURE

I. Establishment.

The Enrollment Subcommittee is hereby established and continued as a standing committee of the Crow Tribal Legislature

II. Membership Advisors.

- A. The Subcommittee shall consist of a minimum of six (6) members of the Crow Tribal Legislature.
- B. The Subcommittee shall coordinate with other Subcommittees, Cabinet head, General Counsel and Legislative Attorney on matters within the Subcommittee's authority and may request appropriate support, advice and counsel on all matters.
- Ill. Purposes.

The purposes of the Subcommittee are:

- A. To establish, amend, and foster policies pertaining to the development of Crow Tribal enrollment and/or membership of the Crow Tribe.
- B. To recommend to the Crow Tribal Legislature the adoption of legislation designed to strengthen the development of the Crow Tribe and to promote the development of the Crow Tribe and its members.
- IV. Powers.

The Subcommittee shall have all powers necessary and proper to carry out the purposes set forth above, including;

- A. To promulgate polices and regulations concerning Enrollment
- B. To propose or review all legislation relating to the committee and enrollment business within the Crow Tribe and shall recommend the adoption or amendment of such laws to the Crow Tribal Legislature,
- C. To receive reports from and to review the operations of all offices, divisions, departments, enterprises, committees, boards, commissions or entities having oversight or control over Enrollment matters.
- D. To establish and maintain policies, rules, regulations and/or law as to the functioning, excluding personnel and/or administrative matters, of the Enrollment.
- E. To hold hearings relative to the functioning, excluding personnel and/or administrative matters, of the Enrollment.



F. To review any and all legislative proposals concerning Enrollment matters upon referral by the Crow Tribal Legislature.

G. These bylaws may be amended upon approval of the Crow Legislature

VI. Meetings.

Meetings shall be held on the _____ of each month.


