A Legislative Resolution Titled:

A Resolution of the Crow Tribal Legislature Establishing an Annual Day of Recognition for the Lodge Grass High School Army Junior Reserve Officers Training Corps

Statement of Legislative Findings:

WHEREAS, the Crow Tribal Legislature ("Legislature") is authorized to adopt resolutions for the governance of the Crow Tribe of Indians pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians.

WHEREAS, Lodge Grass High School is located on the Crow Indian Reservation in the community of Lodge Grass, which is known in the Crow language as the "Valley of the Chiefs";

WHEREAS, Crow Indians have historically distinguished themselves through honoring the United States through service in the Armed Forces;

WHEREAS, on July 1st of 1994 Lodge Grass High School was the first high school in Montana to have an Army Junior Reserve Officers Training Corps (JROTC) program established, as reflected in the 1995 General Order from the United States Army herein attached to this Resolution;

WHEREAS, many young Crow Tribal members have gained important leadership and decision-making skills and other useful training through their experience in the Lodge Grass Army JROTC;

WHEREAS, the Legislature would like to express its pride and appreciation to the Lodge Grass Army JROTC;

Now, therefore, be it hereby resolved by the Crow Tribal Legislature in Regular Session:

That, the 24th day of every September shall be observed and honored by the Legislature as an official day of recognition for the Lodge Grass Army JROTC.

That, this Day of Recognition be observed starting in 2010 and in every year in the future so long as Lodge Grass High School maintains a JROTC program.
