RESOLUTION

No. 49-91(A)

WHEREAS, The Blackfeet Tribal Business Council is the duly constituted governing body within the exterior boundaries of the Blackfeet Indian Reservation, and

WHEREAS, The Blackfeet Tribal Business Council has been organized to represent, develop, protect and advance the views, interests, education and resources of the Blackfeet Indian Reservation, and

WHEREAS, The Blackfeet Tribal Business Council has reviewed and discussed the Blackfeet Tribal Commercial Code on numerous occasions, and more specifically the Chapter on Repossession, and

WHEREAS, The Blackfeet Tribal Business Council has determined that Chapter 4, Section 6(F) entitled "Deficiency Judgment" is not in the best interests of consumers as presently written, for the primary reason that many consumers are being taken advantage of when a repossession occurs on the Blackfeet Indian Reservation, and

WHEREAS, The Blackfeet Tribal Business Council is desirous of amending the aforementioned Section to reflect that no deficiency judgments will be allowed once property is repossessed, now

THEREFORE BE IT RESOLVED:

1. That Chapter 4, Section 6(F) of the Blackfeet Tribal Commercial Code is hereby amended as follows:


"F. Deficiency Judgment

Where a repossession judgment is entered and the value of the property at sale is less than the debt due, the creditor thereafter may not seek a deficiency judgment."

2. That the Chairman and Secretary are hereby authorized to sign this Resolution.
