

Congratulations on your elections as the Constitutional Officers of the Legislature. We look forward to working with you during the coming year on legislation to benefit the Crow people.

This is to request the opportunity for representatives of the Executive Branch to meet with the appropriate Legislative Committees to discuss alternatives to overriding my veto of the following legislation, *prior* to it coming to the floor for votes on overriding the veto:

- 1) CLB No. 11-05: Repeal of CLB 02-17 which authorized limited waivers of sovereign immunity in contracts not exceeding \$1.00; and
- 2) CLB11-06: Request to USF&W to establish MOA for violations of Eagle Protection laws.

We would also appreciate the opportunity to meet with the appropriate Committees on the new legislation submitted by the Executive Branch for the January Session, i.e., Appendix B of the Mining Code, and the Stray Animal protection law.

Please convey my requests above to the Chairs of the appropriate Committees when they have been selected. Thanks for your cooperation.

OCTOBER 2011 REGULAR SESSION OF THE CROW TRIBAL LEGISLATURE

CLB No. 11-05

Introduced by Senator Conrad J. Stewart Co-introduced by Senator V. Jeannie Pretty Paint and Senator H. Noel Two Leggins

For and on behalf of the Black Lodge District

A Bill for an Act Titled:

An Act to Repeal CLB 02-17 and to Amend the Crow Law and Order Code in Order to Establish a Process for Any and All Future Waivers of Crow Tribal Sovereign Immunity to Be Presented to the Crow Legislature for Final Approval in Accordance with the 2001 Crow Constitution.

Legislative Findings:

WHEREAS, under Article V, Section 2(a) of the 2001 Crow Tribal Constitution, the Crow Tribal Legislature ("Legislature") has the power and duty to promulgate and adopt laws, resolutions, ordinances, codes, regulations, and guidelines in accordance with this Constitution and federal laws for the governance of the Crow Tribe of Indians; and

WHEREAS, under Article IV, Section 3(k) of the 2001 Constitution, the Crow Tribal Executive Branch ("Executive Branch") has the power and responsibility to negotiate and approve limited waivers of sovereign immunity when such a waiver is necessary for business purposes in accordance with Article V, Section 2(f) of this Constitution; and

WHEREAS, under Article V, Section 2(f) of the 2001 Constitution, the Legislature has the power and duty to grant final approval or disapproval of limited waivers of sovereign immunity by the Executive Branch of Government when waivers are necessary for business purposes provided that a process for such approval or disapproval may be established by legislation; and

WHEREAS, under Article V, Section 2(b) of the 2001 Constitution, the Legislature has the power and duty to adopt legislation, not inconsistent with the 2001 Constitution, which is necessary in exercising the duties conferred upon the three branches of government; and

WHEREAS, in March of 2002 the Legislature passed CLB 02-17, titled "An Act Authorizing the Executive Branch of the Crow Tribe to Negotiate, Approve, and Execute Any Contract Requiring a Waiver of Tribal Sovereign Immunity Equal To, or Less Than \$1.00 Without Final Approval of the Legislative Branch;" and

WHEREAS, the Legislature now seeks to ensure that all waivers of Crow tribal sovereign immunity be presented to the Legislature for review, analysis, and approval or disapproval and hereby this bill for an act seeks to establish a process for giving such approval or disapproval.

NOW, THEREFORE, BE IT HEREBY ENACTED AS CROW TRIBAL LAW BY THE CROW TRIBAL LEGISLATURE:

That CLB 02-17, titled "An Act Authorizing the Executive Branch of the Crow Tribe to Negotiate, Approve, and Execute Any Contract Requiring a Waiver of Tribal Sovereign Immunity Equal To, or Less Than \$1.00 Without Final Approval of the Legislative Branch" is hereby immediately and completely repealed and made void. And, further, that Title 3, Chapter 2, Part 206 of the 2005 Crow Law and Order Code (titled "Sovereign Immunity") is hereby immediately and completely repealed and made void.

The following process shall govern all future limited waivers of Crow tribal sovereign immunity.

Section 1. PURPOSE

The purpose of this legislation is to establish a process in which the Crow Legislative Branch of Government may review and analyze all proposed limited waivers of tribal sovereign immunity in accordance with Article V, Section 2(f) of the 2001 Crow Constitution. The intent of this legislation is to ensure that all proposed waivers presented to the Legislature from the Executive Branch are fully reviewed and analyzed by the Crow tribal government before approval or disapproval is made by the Legislature.

Section 2. EXECUTIVE BRANCH PROPOSAL

In accordance with CLB 05·11, as codified in Title 1, Chapter 2 of the 2005 Crow Law and Order Code, any Executive Branch proposals for limited waivers of Crow tribal sovereign immunity may be presented as a joint action resolution to the Crow Tribal Legislature. In addition, the proposal may take the form of a bill for an act.

Section 3. LEGISLATIVE BRANCH REVIEW

Upon receiving an Executive Branch proposal, the Secretary of the Legislature shall immediately assign any proposed waivers of tribal sovereign immunity to the appropriate Legislative Branch Committee for review. All Legislative Branch Rules of Order shall apply to any such proposed waivers of tribal sovereign immunity.

Section 4. AMENDMENT TO 2005 CROW LAW AND ORDER CODE

The Secretary of the Legislature shall amend Title 3, Chapter 2, Part 206 to include Section 1, Section 2, Section 3, and Section 5 of this legislation in the next edition of the Crow Law and Order Code. Accordingly, the term "legislation" shall be changed to "Part" when such codification takes place.

Section 5. CROW TRIBAL GENERAL COUNCIL AUTHORITY

Nothing in this legislation shall be construed as limiting the constitutional authority of the Crow Tribal General Council to enact law pursuant to Article IX of the 2001 Crow Constitution, including any such laws addressing limited waivers of tribal sovereign immunity provided that any such General Council action is otherwise consistent with the 2001 Constitution.

Section 6. EFFECTIVE DATE

This legislation shall take effect immediately upon being duly adopted by the Crow Tribal Legislature and its approval by the Executive Branch Chairman or, if no approval is made, at such time as is in accordance with the veto override provisions of Article V, Section 8 of the 2001 Crow Constitution and CLB 06-08.

Section 7. NO RETROACTIVITY

Nothing in this legislation shall effect or be construed as effecting any limited waivers of tribal sovereign immunity entered into lawfully prior to the effective date of this legislation.

JANUARY 2002 CROW TRIBAL LEGISLATURE

BILL NO. CLB0217

INTRODUCED BY: BLAINE BULL TAIL

BY REQUEST OF THE EXECUTIVE BRANCH OF THE TRIBE

A BILL FOR AN ACT ENTITLED: "AN ACT AUTHORIZING THE EXECUTIVE BRANCH OF THE CROW TRIBE TO NEGOTIATE, APPROVE AND EXECUTE ANY CONTRACT REQUIRING A WAIVER OF TRIBAL SOVEREIGN IMMUNITY EQUAL TO, OR LESS THAN \$1.00 WITHOUT FINAL APPROVAL OF THE LEGISLATIVE BRANCH."

WHEREAS, there are many routine day to day business contracts of the Executive Branch of the Crow Tribe that many require a waiver Crow Tribal sovereign immunity where the total amount of the contract is equal to or less than \$1.00.

WHEREAS, the effectiveness of the Executive Branch of the Crow Tribe will be severely diminished if routine day to day business transactions involving contracts of \$1.00 or less cannot be finalized without the Executive Branch first receiving final approval from the Legislature.

WHEREAS, this act establishes a threshold of \$1.00 per contract for the delegation of legislative authority established by the requirements of Article IV, Section 3(k) and Article V, Section 2 (f) of the Constitution and Bylaws of the Crow Tribe of Indians, requiring final legislative approval before such contract is valid.

WHEREAS, this act will empower the Executive Branch of the Crow Tribe with the ability to conduct routine day to day business transactions for the betterment of the Tribe as a whole.

BE IT ENACTED BY THE LEGISLATURE OF THE CROW TRIBE:

NEW SECTION. Section 1. Waiver of sovereign immunity in contracts with a value equal to or less \$1.00 by the Executive Branch allowed without final approval of legislature. (1) The Executive Branch of the Crow Tribe of Indians may negotiate, approve and execute any contract requiring a waiver of tribal sovereign immunity without the requirement of final legislative approval provided that the amount of any one contract shall not exceed \$1.00.

NEW SECTION. Section 2. Ratification of Existing Leases. (1) All existing leases (waivers) granted by the Crow Tribal Executive Branch equal to or below the threshold amount established herein ... are hereby adopted as valid.... All existing leases (waivers) granted by the Crow Tribal Executive Branch since July 14, 2001 that are in excess of the threshold amount established herein must be presented to the Crow Tribal Legislature for ratification at the April, 2002 Legislature Session."

<u>NEW SECTION.</u> Section 3. The threshold amount of \$1.00 implemented through this Bill supercede and nullify any threshold amount previously approved by the Crow Tribal General Council or any previous Tribal administration."
