JOINT ACTION RESOLUTION NO. JAR0216

**INTRODUCED BY: REPRESENTATIVE WILLIE PLAIN FEATHER,
BIG HORN DISTRICT**

A JOINT RESOLUTION OF THE LEGISLATIVE BRANCH REQUESTING THAT THE HEALTH AND HUMAN SERVICES OF THE CROW TRIBAL GOVERNMENT BEGIN AN INVESTIGATION INTO THE NUMBER OF SERIOUS INJURIES AND DEATHS OCCURRING TO TRIBAL ELDERS RESIDING IN THE AWE KAULAWACHE CARE CENTER LOCATED IN CROW AGENCY, MONTANA

WHEREAS, the Crow Tribal Elders are a valuable asset;

WHEREAS, a large number of Tribal Elders reside and receive medical care at the Awe Kaulache Care Center in Crow Agency, Montana;

WHEREAS, the growing number of deaths and serious injuries of Tribal Elders while they are residing at the Awe Kaulache Care Center is of great concern to both the Executive and Legislative Branches of the Crow Tribal Government;


BE IT JOINTLY RESOLVED BY THE LEGISLATIVE AND EXECUTIVE BRANCHES OF THE CROW TRIBE:

That the Executive Branch of the Crow Tribal Government, at the request of the Legislative Branch of the Crow Tribal Government, begin an immediate investigation into the alarming number of deaths and serious injuries occurring to Tribal Elders while under the care of Awe Kaulache Care Center, and the Executive Branch further agrees to provide a detailed report of the findings from such investigation to both branches within three (3) months of passage of this Joint Resolution.
