**INTRODUCED BY CARL E. VENNE, CHAIRMAN
CROW TRIBAL EXECUTIVE BRANCH**

**JOINT ACTION RESOLUTION OF THE CROW TRIBAL LEGISLATURE AND THE
CROW TRIBAL EXECUTIVE BRANCH ENTITLED:
“A RESOLUTION OF THE CROW TRIBE AUTHORIZING AND SUPPORTING
THE SUBMISSION OF THE BILLINGS AREA CONSORTIUM’S APPLICATION FOR
THE IHS SDPI COMPETITIVE GRANT PROGRAM
FOR CARDIOVASCULAR DISEASE RISK REDUCTION.”**

WHEREAS, the Indian Health Service (“IHS”) has announced a competitive grant program under the Special Diabetes Program for Indians (“SDPI”) for a demonstration project to implement and evaluate defined activities in the area of prevention of cardiovascular disease in people with diabetes; and

WHEREAS, through the Montana-Wyoming Tribal Leaders Council, the Tribes of the IHS Billings Area have formed a “Billings Area Consortium” for the purpose of applying for the SDPI cardiovascular disease grant, with the application to be submitted by the Fort Belknap Community Council (the “applicant”) on behalf of the Consortium; and

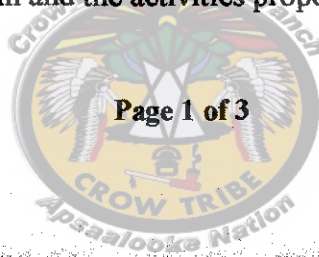
WHEREAS, Article IV, Section 3(b) of the Constitution and Bylaws of the Crow Tribe grants the Executive Branch the powers and responsibilities of representing the Crow Tribe in negotiations with the Federal government and its agencies in matters of welfare, education and social services, and the Chairman of the Executive Branch has previously issued an Executive Branch Resolution in support of the Consortium’s letter of intent to apply for the grant; and

WHEREAS, the Crow Tribe has a substantial population of people with diabetes and a high risk of cardiovascular disease, and has an urgent need for additional education and services in this area;

NOW, THEREFORE, BE IT RESOLVED BY THE CROW TRIBAL LEGISLATURE:

1. That the Crow Tribe hereby authorizes and supports the application of the Fort Belknap Community Council on behalf of the Billings Area Consortium of Tribes (including the Crow Tribe) for the SDPI competitive grant program for prevention of cardiovascular disease. In support of the application, the Crow Tribe agrees as follows:

(a) That the applicant officially represents us on all matters related to the SDPI Competitive Grant Program and the activities proposed in this application;




- (b) To participate in this project as described in the application;
- (c) To support the applicant so that they may fulfill the requirements of the SDPI Competitive Grant Program, including implementation of all activities related to the demonstration project and submission of any data or reports for the evaluation of this project as required by the IHS National Diabetes Program IHS Grants Management Branch, and the Coordinating Center;
- (d) To review documents, paperwork, reports, and manuscripts as requested by the applicant and the IHS National Diabetes Program in a timely manner, and agree that if we do not review them within 30 days, our failure to respond will be treated as concurrence and the documents can then be submitted or disseminated as planned by the applicant and as required by the IHS; and
- (e) We understand that failure to participate as planned or to support the applicant in their fulfilling requirements of this initiative may result in termination of our participation and/or the applicant losing their funding.

2. That the Crow Tribal Legislature requests that the IHS National Diabetes Program accept this Joint Action Resolution as evidence of our strong support and approval of this applicant and its application for the SDPI Competitive Grant Program funding.

CERTIFICATION


