**LEGISLATIVE RESOLUTION OF THE CROW TRIBAL LEGISLATURE
ENTITLED:**

“APPOINTMENT OF KENNY E. PRETTY ON TOP AS SERGEANT AT ARMS”

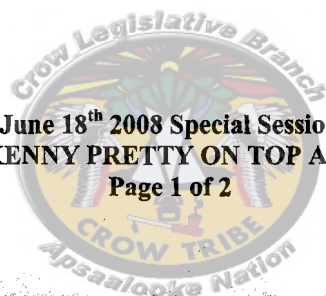
WHEREAS, The Crow Tribal Legislature is authorized to adopt resolutions, regulations and guidelines for the governance of the Crow Tribe of Indians, pursuant to Article V, Section 2(a) of the Constitution and Bylaws of the Crow Tribe of Indians, approved by the Secretary of the Interior on December 04th 2001; and

WHEREAS, The Crow Tribal Legislature approved Rules of Order to provide for orderly and efficient Legislative sessions; and

WHEREAS, upon working with the approved Rules of Order, the Crow Tribal Legislature has found that a Sergeant at Arms is needed to serve as parliamentarian to ensure compliance with the Rules of Order.

WHEREAS, it is also vital to appoint a Sergeant at Arms to ensure the environmental safety of the Legislative Branch of Government.

WHEREAS, the appointed Sergeant at Arms shall be compensated.



NOW THEREFORE, BE IT ENACTED BY THE CROW TRIBAL LEGISLATURE

THAT, THE CROW TRIBAL LEGISLATURE HERBY THIS ACTION OFFICIALLY APPOINTS KENNY E. PRETTY ON TOP AS SERGEANT AT ARMS TO ENSURE THE COMPLIANCE, SAFETY, AND SECURITY OF THE LEGISLATIVE BRANCH OF GOVERNMENT.


FURTHER, THAT, IN APPROVAL OF THIS LEGISLATIVE RESOLUTION, KENNY E. PRETTY ON TOP SHALL BE SERGEANT AT ARMS AND PARLIMENTARIAN DURING QUARTERLY/SPECIAL SESSIONS HENCE FORTH.

FURTHER, THAT, KENNY PRETTY ON TOP, SERGEANT AT ARMS SHALL CONDUCT AND ENFORCE ALL AUTHORITY INVESTED IN RULE (6), SERGEANT AT ARMS, OF THE CROW TRIBAL LEGISLATURE RULES OF ORDER.

FINALLY, THE APPOINTED SERGEANT AT ARMS SHALL BE COMPENSATED DETERMINED THROUGH CONSENSUS OF THE LEGISLATIVE BODY.


