**A LEGISLATIVE RESOLUTION OF THE CROW LEGISLATURE
ESTABLISHING AN INCREASE FOR THE LEGISLATIVE MEMBERS
EFFECTIVE OCTOBER 1, 2008**

WHEREAS; the crow Legislature is a separate Branch of the Crow Tribe as established by the Crow Constitution, and

WHEREAS: The Crow Legislative Members have thoroughly examined the matter of an increase for the Legislative Members to take effect October 1, 2008, and

WHEREAS; the Crow Legislature has passed a budget for the Crow tribe of Indians for FY 2009, and

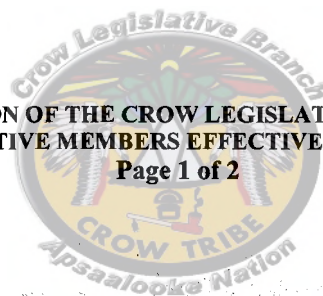
WHEREAS; the Crow Tribal Legislative Budget contained funds for an increase for the Members of the Crow Legislature

NOW THEREFORE, BE IT HEREBY RESOLVED:

EFFECTIVE OCTOBER 1, 2008 EACH MEMBER SHALL RECEIVE AN HOURLY INCREASE IN THE AMOUNT OF \$2.00.

AND BE IT FURTHER RESOLVED:

THE OFFICE ADMINISTRATOR FOR THE CROW LEGISLATURE IS HEREBY AUTHORIZED AND DIRECTED TO INITIATE AND FILE ALL NECESSARY PAPERWORK TO IMPLEMENT THE INCREASED HOURLY RATE FOR THE LEGISLATIVE MEMBERS ONLY.


CERTIFICATION
