A Legislative Resolution Titled:

**A Resolution of the Crow Tribal Legislature to Modify the Fiscal Year 2011  
Legislative Branch Budget**

Legislative Findings:

**WHEREAS**, the Crow Tribal Legislature (“Legislature”) has the power and duty under Article V, Section 2 of the 2001 Crow Constitution to promulgate and adopt resolutions and guidelines in accordance with the 2001 Constitution and federal laws for the governance of the Crow Tribe; and

**WHEREAS**, the Legislature is responsible for and in control of its budget for fiscal year 2011; and

**WHEREAS**, the Legislative Branch Revenue Committee (“Revenue Committee”), pursuant to Section IV(B) of the Committee By-Laws, has the power to recommend to the Legislature amendments and modifications to the approved annual budget; and

**WHEREAS**, the Revenue Committee has reviewed current and projected fiscal year expenditure amounts and the available remaining Legislative Branch budget; and

**WHEREAS**, the Revenue Committee has determined, after review and deliberation of the budget and Legislative Branch priorities and policy goals, that it is in the best interests of the Legislature to modify the fiscal year 2011 Legislative Branch budget in accordance with this resolution.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CROW TRIBAL  
LEGISLATURE IN SPECIAL SESSION:**

That the Crow Legislative Branch budget is hereby deemed amended as follows:

**BE IT HEREBY FURTHER RESOLVED:**


That, this resolution shall take effect immediately upon becoming duly adopted by the Legislature.

That, a certified copy of this resolution shall be immediately delivered to the Tribal Comptroller and Tribal CPA by the Secretary of the Legislature.


**CERTIFICATION**




